## **Attachment 2 to the Power of Attorney for Airtrans Sp. z o.o. Sp.k.**

### Authorizing and ordering services

1. I hereby undertake to update all relevant documents and inform in writing of any changes of registry date (e.g. company seat, representation, etc.) as well as of any actions taken by the company or third persons under the bankruptcy law within 7 days from the date of these changes or actions.
2. The Principal hereby declares that he is not subject to any judicial or administrative execution decisions or proceedings. All tax and duty debts are settled by the Principal in due time.
3. I hereby undertake to maintain due care in preparation and delivery of relevant documents required for each individual customs declaration. In particular:
  - a. accurate translation of the commercial invoice to polish including the translator's legible signature and ID no.;
  - b. complete documents and necessary information describing the shipment, license fees and other factors affecting the goods customs value and tax basis;
  - c. the Principal shall be liable for the compliance of the goods with the documents provided for the customs clearance.
4. I hereby undertake to provide – as required by the customs authorities – any additional information or documents necessary for correct customs clearance and relevant for the customs inspection.
5. Aware of the criminal liability under the criminal law I hereby declare that the goods handed to AIRTRANS for the customs and logistic handling within the international commercial turnover:
